What is advocacy?

Advocacy is the process of trying to influence decision-makers and public opinion. An advocate is a supporter, a campaigner, a sponsor, an activist in support of a particular cause or group of people. We often think of advocacy only in terms of government. While that's important, we can act as advocates in many other ways: with people at church, and among neighbours and friends.

Doing your home work

Your issues check list (write what you know below or what you still need to learn, or what you have questions about):

□ **Your knowledge of the issue** List the facts you know; don't know; need to know. To be effective, you need to go beyond just vaguely feeling something is wrong.

The history of the issue. How did the issue come about? When? Who is affected by it?

Preparing questions for the decision-maker What framework or perspective of the decision-maker are you working from? Develop your questions out of stated policy or vision/value statements which frame your specific policy request. Ask for an explanation of how something is supposed to work, and why it may not work in a particular person's situation. *Don't begin with an attack!*

Closing Prayer (All standing)
