Re: Q3 2013 performance of the Cemetery Fund

The Short Summary and Investment Performance Summary provided by Scotia Asset Management for the Cemetery Fund as of September 30, 2013 is attached. This Short Summary provides information of the fund by asset class, i.e. Cash, Fixed Income, Canadian Equities and U.S. Equities. As of September 30, 2013 the asset mix is in line with the current Diocesan policy.

The Investment Committee of the Diocese of Toronto compares the performance of the Cemetery Fund to a benchmark of:

DEX Universe for Fixed Income bonds TSX Composite for Canadian Equities S&P 500 for U.S. Equities

The Investment Performance Summary shows that the Cemetery Fund outperformed the benchmarks in Canadian Equities, Bonds and Total Portfolio Returns for the third quarter in 2013 and outperformed the benchmarks in all asset classes for the last 12 months (1 year).

The current manager and trustee fee paid to Scotia Trust is 0.35%.
