This is the report of the Synod Council to the members of the 163rd Regular Session of Synod. This report covers the period July 1, 2023, through June 30, 2025. During this period, Synod Council held 17 video conference calls using Zoom and had 8 email polls for a total of 25 meetings. On September 13, 2025, Synod Council approved this report.

Policy Matters and Major Items Discussed or Approved (in alphabetical order)

o Area and Area Council Working Group

This group began its work after the suspension of Canon 43 & 44. Three options were presented to multiple stakeholder groups to gather further insight into changing the area structure. The suggestion was made to ask for the resuspension of Canon 43 & 44 at Synod 2025 in the hopes of putting a pilot project in place for a trial period.

o Cast and Learn Grants





Cast and Learn grants address a gap in our program have allowed parishes to ask for funding between \$10,000 and \$40,000. They have been used numerous times in the last 2 years.

Cast the Net & Netminders

The Cast the Networking group completed their work, having Council endorse the Vision and Calls for the diocese that they put forward after an extensive consultation process. This was approved in principle in February 2024 after an in person meeting of Synod Council. The Cast the Net Visioning Team was created which is now known as the Netminders. The final report was issued and accepted.

Database Project

The diocese has begun work on a project that is necessary to enhance security and connectivity. Vendors have been solicited and one was chosen. The project is being worked on and assessed for functionality. Implementation has begun. Funding for this project was through Our Faith Our Hope "Communicating in a Wireless World".

o FaithWorks

Synod Council approved the FaithWorks Goal for 2024 and 2025 of \$1,500,000.

o MAF Grants & Loans

These grants and loans are offered in 3 broad categories: real estate, congregational growth and ministry resources and creating new forms of ministry. There were numerous over the last 2 years that were approved by Synod Council based on PEMG's recommendations.

Monthly Committee Reports

Finance, Human Resources, Property and Risk and Governance Committees submit monthly reports based on their meetings. The reports update Council on the work being done what Council needs to approve for that work to move forward.

Pre-Development Fund

This fund was created to be used as a strategic initiative to support sustainable development projects. Property and Finance Committees will recommend guidelines for the administration and utilization of the funds before any funds are issued.

Process and Planning Group

The Process and Planning Group continued its work in shaping and planning the agendas for meetings of the Synod Council.

Quarterly Fiduciary Reports





Council members received regular fiduciary reports consisting of a Litigation Report, Compliance Certificate and Financial Results.

Season of Spiritual Renewal

The Rev Canon Dr Judy Paulson was hired to oversee the Season of Spiritual Renewal that came from the Cast the Net Report. Plans for the work to be done are updated regularly to Synod Council.

Stretch Grants

These are one-time grants that are meant to boost the reach and ministry of successful projects in the Diocese. They range from \$5,000 to \$20,000 in amounts and fund new and innovative ministries that focus on reconciliation, lay leadership, evangelism, social action, justice and creating a culture of gratitude.

- Parish Administration, Amalgamations, and other Arrangements

- Canon 24 Diocesan Administration of Parishes
 - Oakden and Bill Matthews, ODT are working together with this parish. This admin team was given a year mandate that was expanded into a 2nd year.
 - O Good Shepard, Stayner This parish was removed from the Barrie Regionalization and linked with the South Georgian Bay Regionalization in 2024. They have a Canon 24 admin, Dr. Catherine Raaflaub, who began in September of 2024 to navigate the financial difficulties and work with them as they integrate in the regionalization.
 - Huronia Regionalization The Huronia Regionalization was put under Canon 24 Oct 17th, 2024, as the regionalization was built. Canon Laura Walton, ODT covered:
 - Good Samaritan, Port Stanton
 - St. Paul Washago
 - St. Luke, Prices Corner
 - St. David, Lutheran Anglican Church, Orillia
 - St. George, Fairvalley
 - St. John's, Waverly

Once Archdeacon John Anderson becomes Incumbent of the Regionalization in 2025 the Canon 24 coverage will be rescinded.

St. Andrew, Japanese/St, David, Donlands

At its October 20, 2022, meeting, Synod Council approved the voluntary amalgamation of St. David, Donlands and St. Andrew, Japanese. In December





2022, Charles Cutts was appointed the Administrator to help the parish navigate the amalgamation process. He stayed on to continue the work after amalgamation.

St. Andrew, Scarborough – Canon 24 administration began December 31, 2024.
 Stephen Masson, ODT and Yvonne Murray ODT share this role.

St. Bartholomew, Toronto

This parish has been under diocesan administration since 2012 under Canon 24. Kevin Forrest continues to serve as the Administrator.

St Chad

In March 2022, Council approved that St. Chad be immediately placed under Canon 24. Since October 2022, Philip Conliffe continued to serve as the Administrator until the parish was disestablished in February 2024. The disestablishment occurred after the Report of the Bishop's Commission of Investigation was received and its recommendation implemented.

- St. John, West Toronto The Canon 24 admins were put in place June of 2024.
 Stu Hutchison, CMS ODT, Brother Reg Crenshaw OHC ODT and Mario Barolozzi, ODT share this role.
- St. Matthias, Bellwoods The parish was placed with a Canon 24 Administrator, Julie Kretchman on June 24, 2024.

Disestablishments

O St. Chad

Synod Council acknowledged the disestablishment of St. Chad at its January 2024 meeting. The last service was held February 11, 2024. The building remains consecrated and a decision about the future of the building will be made later.





o St. George, Newcastle

Synod Council acknowledged the disestablishment of St. Geroge, Newcastle at its May 2024 meeting based on CRA requirements.

St John, West Toronto

Synod Council received the report from the Canon 13 Commission of Investigation for St John, West Toronto. They confirmed the recommendation therein that the parish should be closed as of July 30, 2024.

o St. Stephen, Maple

Synod Council acknowledged the disestablishment of St. Stephen Maple at its October 2023. The last service was on October 1st, 2023. The building remains Consecrated.

Sabbath Rest

The following churches are currently in a period of Sabbath Rest for an undetermined period of time. The buildings remain consecrated in the hope that this time of rest will allow time to assess ministry and that one day the churches will reopen for ministry and public worship.
