and Communities

Criteria

The Anglican Diocese of Toronto seeks to honour and respect Indigenous self-determination and sovereignty on this Territory and is committed to the process of reconciliation. As per the will of Synod 2021 (the Diocese's semi-annual collective and decision-making gathering), the Reconciliation Land Tithe (Motion 12) was passed to provide 10% of net annual property sales to go towards Indigenous Nations and Communities as a commitment to reconciliation.

The Reconciliation Land Tithe will fund a wide variety of projects that contribute to the physical, intellectual, emotional, or spiritual well-being of Indigenous communities. Programs of cultural revitalization, that provide healing and support, respond to emerging needs, and advance reconciliation efforts are strongly encouraged. The Anglican Diocese of Toronto recognizes the profound harm to Indigenous Nations and communities through the church's participation in colonialism and the Residential School system. This granting body is committed to providing redress and restitution to the ongoing legacy of Christian colonialism. In the spirit of the principles of reconciliation outlined in the 94 Calls to Action of the Truth and Reconciliation Commission, the Reconciliation Land Tithe respects Indigenous self-determination and autonomy of the applicants. Funding is to be provided in the terms outlined in this document. The Reconciliation Land Tithe Committee (RLTC) encourages dialogue and relationship building with grant recipients. The RLTC and Anglican Diocese of Toronto will not make public your application or work. Please do not hesitate to reach out to the RLTC to provide feedback on this process, share how your initiative is going, how the church might be in solidarity with your community, or how we might provide any additional or ongoing support.

Projects and proposals do **not** need to be connected in any way to the Anglican church or Christian faith. This funding is grounded in restitution for the spiritual and total harm of the Indian Residential School system and its ongoing legacy.

Annual application deadlines are June 15th and November 1st

Grants for both ongoing and emerging projects will be considered. Projects that are concluded before the application date will not be considered.

Category A Grants: Local Up to \$25,000

Category A grants will be considered based on impact and how they support Indigenous communities in a local context. The number of these grants will depend on the availability of funds and the number of applications received.

Category B Grants: Regional Up to \$50,000

Category B grants will be considered based on impact, project scope, and how they support the overall service to Indigenous communities in a city or region. The number of these grants will depend on the number of applications received.

Category C Grants: Local and/or Regional Up to \$50,000/year – multi-year project

Category C grants are multi-year grants. They will be considered based on impact, project scope, and how they support the overall vision and service to Indigenous communities in a local, regional, or territory. The number of these grants will depend on the number of applications received.

Proposals must meet the following criteria:

- Must contribute to the physical, intellectual, emotional, or spiritual well-being of Indigenous Nations and/or communities.
- Must be Indigenous-led, involving Indigenous people in project development, planning, and implementation. References or connection to an Indigenous Nation, Reserve, Sacred Circle, and community may be asked to ensure the proposal is Indigenous-led.
